- Do not feed any horses or approach them on the yard or in the stable.
- Riding hats to current safety standards to be worn whilst riding or on the ground around horses. If you bring your own it must be checked by the tutor. We are not qualified hat fitters and do not accept responsibility for checking that they fit.
- Hand washing is advised after contact with horses.
- Do not enter arenas without permission.
- No climbing on the haystacks, jumps, gates, fences or stables.
- No smoking.
- Please observe where the fire assembly point is. Do not tackle any fire. Please inform the tutor if you notice a fire. Fire drills do take place. Please listen to the tutor for guidance in such cases.
- No toys on the yard.
- Unreasonable behaviour toward any person or animal will result in expulsion.
- All dogs are to be kept on a lead and their mess cleared up.
- Do not enter the farmhouse gardens.
- Please inform us of any change of address, phone numbers, medical / personal information.

- Riding Attire:
 - Hair longer than collar length should be in a low pony tail covered by a hair net. No hair clips or bands etc.
 - Long trousers, leggings, jogging bottoms or jodhpurs.
 - Gloves with pimple palms
 - Long sleeves to be worn at all times.
 - Body protectors are advised for all riding activities.
 - Jodhpur boots, long riding boots or an equivalent boot. The correct footwear must be brought by the 6th lesson. Failure to do so will result in the rider not being allowed to ride. You will be liable for the lesson payment in such circumstances. All boots must be clean prior to riding.
 - No jewellery when riding or working around horses.
 - No shorts, T-shirts, skirts, strappy tops, 3/4 length trousers or clothes with excessive belts, buckles and tassels or dangling bits.

- A booking form with a deposit must be received to secure a place on any event other than riding lessons or hacks, unless otherwise stated.
- Saturday client lessons are pre-booked for you on a 6-8 week basis. These bookings will continue to be booked for you unless we receive different written instructions from you. Lessons, dates and times will be available from your tutor.
- Weekday riders must book all lessons with their tutors.
- Please read all safety / risk assessment notices in the barn and around the yard.
- Insurance, Licenses and any other information you require to see is displayed in the yard office.
- **48 Hours** notice of cancellation for lessons or events is required to be given, otherwise the full fee is payable whatever the circumstances.
- We do allow children aged 13 years and over to “help out”. Please ask for more information.
- With the exception of the summer holidays, lessons continue throughout school holidays, unless otherwise informed.
- Due to the nature of Equestrian Sport, it may be necessary to use some physical contact when assisting with mounting and dismounting, when adjusting rider positions or tack or when administering first aid.
- Failure to arrive for 2 consecutive lessons without prior cancellation will result in all future lesson being cancelled.

Cobbles Farm employees, animals, helpers, liveries and owners cannot be held responsible, nor entered into any negligence or liable claim for loss, damage or injury to any client, friend, relative, pet or personal belonging, how so ever caused. While we take every care to ensure that horses are suitable for riders assessed to be at appropriate levels, horses can be unpredictable at times.

I fully understand that Horse Riding and Care is a high risk sport.
If I fail to give 48 hours notice of cancellation or fail to arrive for any booked lesson or event, I will be responsible for the full payment.
